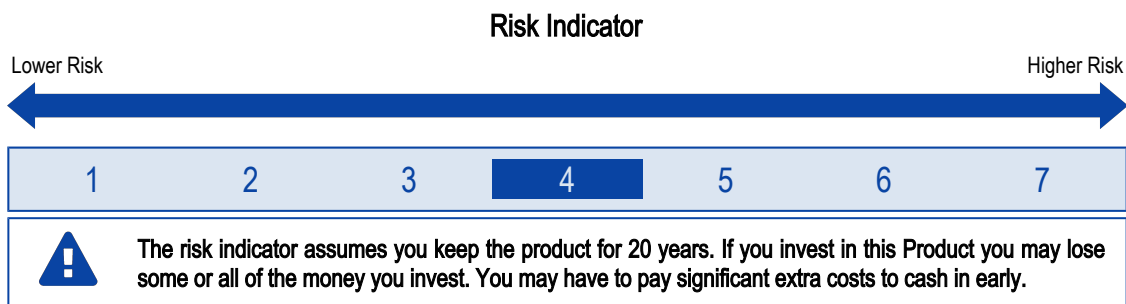

What is this investment option?

Investment Objectives: The Fund aims to produce a constant return expressed in euro, by adopting an aggressive investment strategy. The Fund invests primarily in local and international bonds and equities. For operational purposes the LifeStar Fund may hold a proportionately small amount of its holdings in cash. The performance of these fund will be available on our website and we will send you a yearly statement on your policy anniversary.

Intended Retail Investor: The fund is intended for a retail customer with high risk appetite, who plans to invest more than 25 years, without withdrawals. The aggressive investor has an above average tolerance for overall risk in the investment portfolio, seeks to attain growth which would significantly improve the purchasing power of the capital and is best geared for pension plans with a 25 years plus time horizon before drawing the pension. Before purchasing this plan your intermediary will ask you a set of questions to verify that this plan meets your objectives and falls in line with your risk and reward appetite.

What are the risks and what could I get in return?



- The Summary Risk Indicator, seen hereunder, is a guide to the level of risk of this plan carries when compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are unable to pay.
- We have classified this fund in risk category 4 (out of 7), which is considered a medium risk class. This rates the potential losses from future performance at a medium level.

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product performs. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 5.7% before costs and 5.2% after costs.
